#### **NURJAHAN BEGUM**

# Yunus Centre advisor and Former Managing Director of Grameen Bank

Ms. Nurjahan Begum, currently working as advisor to Nobel Laureate Professor Muhammad Yunus, has an outstanding career with the Grameen project since the inception of the Grameen Bank in 1976. She was one of the earliest associates of Professor Yunus during the establishment of the bank and became Acting Managing Director in 2011 when Professor Yunus decided to leave. She served as Principal of Grameen Bank Central Training Institute and General Manager, Training & Special Program and Deputy Managing Director of the Grameen Bank. Currently, she is the director of Grameen Italia Foundation, the Center for Mass Education in Science and Grameen-phone Ltd in Bangladesh, as well as of Grameen Foundation in the USA.



#### **AMY COUGHENOUR BETANCOURT**

#### Chief Operating Officer for International Programs, NCBA CLUSA

Ms. Amy Coughenour Betancourt is NCBA CLUSA's Chief Operating Officer for International Programs. She oversees a \$220 million portfolio in 19 countries in Africa, Latin America, and SE Asia in the areas of food security and nutrition, cooperative development, agriculture and resilience, civil society strengthening, and democracy and governance, focused on building the capacities of vulnerable populations, including women and youth. She serves on the boards of the Overseas Cooperative Development Council and InterAction, the premier INGO association in the United States.



#### **VIC VAN VUUREN**

# International Labour Organization, Enterprise Department Director

As Director of the Enterprise Department, Mr. Van Vuuren oversees a large portfolio of programs that aim to create decent work in supply chains. The Enterprise Department promotes decent work by supporting sustainable enterprises and strengthening the institutions and governance systems. Mr van Vuuren joined the ILO in 2009 as the Director of the ILO Decent Work Team for Southern and Eastern Africa. Prior to joining the ILO, he was the Chief Operations Officer at Business Unity South Africa and representative for business at the South African Economic, Development and Labour Council (Nedlac).



#### **PATRICIA AKAKPO**

#### CSO Partnership for Development Effectiveness Co-Chair

Based in Ghana, Ms. Akakpo works as the Programme Manager for the Network for Women's Rights in Ghana (NETRIGHT) and serves as the CPDE Co-Chair for Membership and Internal Communications while providing guidance to the Communications Working Group. She has a number of published works focusing on feminism, gender, women's rights and women empowerment and over 15 years of experience in the field of gender & development, human resource management, movement building, labour relations and programme management.



#### **UY-TAN STEPHANY**

#### Mayor of the Catbalogan City, Philippines

Ms. Stehphany Uy-Tan was elected as mayor of Catbalogan in 2013, after having served as Barangay Chairperson since 2007 and being elected city councilor in 2010. She pledged for an inclusive and participative form of governance with a focus on health, environment, and sanitation; tourism and investment promotion; education and economic development. Confronted by various typhoons and natural disasters, her administration realized the need for resiliency and a sustainable urban development, which led to the innovative concept "Sky City" project. This large-scale initiative caught the attention of the global community while reaping local partnerships for the realization.



#### MARIA CASTILLO FERNANDEZ

#### Ambassador, Head of Delegation of the EU to Malaysia

Ms. Castillo, currently Head of Delegation of the EU to Malaysia, has an extensive political career strongly linked to the European Union, since 1989 when she started as a Legal Advisor at the European Commission in Brussels. In 2012, after being the Head of Office of the European Union in Hong Kong and the Deputy Head of Mission at the EU Delegation in Seoul (Republic of Korea), she became the Head of Division for India, Nepal, Bhutan, and Bangladesh at the European External Action Service (EEAS) of the European Union. She is managing and coordinating the European Union's overall relations with South Asian countries and the South Asia Association for Regional Cooperation (SAARC).



#### MANZI ERIC

#### Secretary General, CESTRAR, SG Moto-Taxi Coop Rwanda

Mr. Manzi is a long-term advocate for the implementation of new cooperative strategies. He has a vast experience in mediating and advocating for a closer cooperation between the trade union and the cooperative movements in Rwanda. As the Secretary-General of Rwanda Trade Union Confederation (CESTRAR) organization affiliated to ITUC since 2001, he is taking care of different field partnership projects in the field. The Taxi moto transporters cooperative is one of the most successful partnership cases. Additionally, he is the Vice-chair of Rwanda Labour Council, a substitute member organization of the ILO governing body and chair of the Subregional Trade Union Confederation of East Africa (EATUC).



#### EDUARD MARPAUNG

#### General Secretary, KSBSI Indonesia - International Trade Union Confederation

Mr. Marpaung, General Secretary of the Confederation of Indonesia Prosperity Trade Union (KSBSI), has had an extensive career in the Indonesian trade union movement since 1992. As KSBSI's General Secretary he is taking care of all the activities related to the development of cooperatives across Indonesia. For the past years KSBSI, one of ITUC's affiliated organisations in the country, has deployed dynamic strategies to boost the cooperative model throughout the Indonesian territory, establishing more than 700 cooperatives both in formal and informal economic sectors.

#### Executive Director, Federación de Cooperativas de Ahorro y Crédito de El Salvador Mr. Cordova is the Executive Director for the Federation of Credit and Savings Cooperative Unions in El Salvador and

With over 32 years of experience in financial cooperatives, he is also the founder of NGOs and other people-centred initiatives such as: Central American Institute of Financial Studies (IDEFICA), National Development Foundation (FUNDE), INFORED Credit Union, and the Central American Institute of Research for Development. Mr. Cordova was appointed as the Director of CONAMYPE, the National Commission for Micro and Small Enterprises, by the President of El Salvador, from 2009-2012 and he participated in various law and consumer protection reforms.



#### MARCE SOARES

#### Member Services Manager, Cooperativa Café Timor

Ms. Soares has served as the only female manager within Cooperativa Café Timor (CCT), Timor Leste's largest agriculture cooperative, since 2008. She started as the Health Division Manager until 2016 when she transitioned to the role of Member Services Manager. As the CCT's Member Services Manager, Ms. Soares manages the social services that the organization offers to its members, such as health services and gender and social inclusion, including family income management. Additionally, she developed CCT's first Gender and Social Inclusion training module for the cooperative's health division staff and agriculture extension agents.
